CAS Student Essay Prizes – The winners of the 2018 prizes were as follows:

- **Graduate prize** – Sean Patterson (University of Alberta) for his essay “Prefiguring Privilege: Mennonite Self-Defence as a Symptom of Imperial Decolonization.”
- **Undergraduate prize** – The prize was awarded to two students: Flora Deverell (McGill University) for her essay “Rushing the Maidan: Understanding the Relationship between the 2004 Orange Revolution and the 2013-14 Revolution of Dignity in Ukraine;” and Hannah Rudderham (University of Alberta) for her essay “Who Wore the Uniform? The Question of Soldier Identity in Revolutionary Russia, February-October 1917.” I am also delighted to see that Hannah is on the conference program this year.

Thank you to Eduard Baidaus, Natalie Kononenko, and Irene Sywenky for serving on the prize committee.

CAS/Taylor & Francis book prize – this year's prize was awarded to Lynne Viola for her monograph entitled, *Stalinist Perpetrators on Trial: Scenes from the Great Terror in Soviet Ukraine* (Oxford University Press, 2017). Thank you to Joy Demoskoff, Allan Reid, and Maryna Romanets for their work on the committee that decided the award. Submissions for the next prize have just come in and I am sure the new committee is already hard at work reading the titles. I would also note that Taylor & Francis have generously increased the prize to \$500 from the \$250 that it used to be.

CAS/Taylor & Francis article prize – the inaugural CSP Article of the Year award has been given to Jeffrey S. Hardy, whose article “Of pelicans and prisoners: avian–human interactions in the Soviet Gulag,” appeared in a special issue of *Canadian Slavonic Papers* that was guest-edited by Eva Plach. Thank you to the members of the CSP editorial board – specifically Norman Pereira, Christine Worobec and Allan Reid – who, along with Heather Coleman,

evaluated the articles. The generosity of Taylor & Francis should be recognized since they are providing \$250 to the winner and making his article available for free downloading.
