#### MAJOR COURSE REQUIREMENTS:

A Honors route for graduate study in Economics requires:

- ECON 101 and 102, MATH 125, 154 and 156, STAT 161 or equivalent,
- ECON 281, 282, 299, 384, 385, 386, 387, 399, 481, 482, 497,
- Two additional courses at the ECON 400 level.
- STAT 161 and ECON 299 can be substituted by STAT 265, 266.
- The Honors essay route requires a cornerstone project, but does not require ECON 387 and 497.

### WHAT CAN I DO WITH AN ECONOMICS HONORS DEGREE?

Graduate studies in economics, political science, or law. Research assistant, such as for the Bank of Canada.

### EARLY DEGREE
