# Director's Message

For almost four decades, members of the John Dossetor Health Ethics Centre have supported the advancement of interdisciplinary dialogue, community, and scholarship in health ethics. This past year has been no different as we celebrate the offerings and achievements of the Dossetor Health Ethics Centre for the 2023 / 2024 academic year.

Highlights for this year include our November 2023 health ethics symposium on *Rural and Remote Healthcare Ethics: Considering Issues for the Past, Present, and Future*, which brought together healthcare providers and other interested parties from across and beyond Alberta. In comparison, our health ethics seminar series, which ran from September 2023 to June 2024, covered a variety of challenging topics in health ethics; equity, diversity, and inclusion; and, intersections of health ethics and health law drawing an international audience. From an education perspective, members of the center continued to offer small and large group to health professional students spanning the health sciences college. This encompassed not only classroom-based learning in medicine, nursing, and other health sciences programs; it also included experiential learning around challenging cases in clinical environments and student electives in clinical ethics. Finally, we highlight in this report some of the research products of our members.

As a University of Alberta center, we recognize the importance of social accountability as we strive for our offerings to reflect the education, research, and clinical service needs of interested parties within and beyond our institution. This includes exploring perennial and contemporary issues in health ethics such as disability ethics, ethical decision-making around use of medical technologies, medical assistance in dying, artificial intelligence in healthcare, end-of-life healthcare ethics, moral distress, parental discretion and children's rights, issues of confidentiality and privacy, and so forth. As you read through this annual report, we welcome your thoughts, questions, and comments should you desire to share them.

# Vision, Mission, Values

## Our Vision

To build dialogue, reflection, and understanding surrounding contemporary issues of health ethics within and beyond the University of Alberta.

## Our Mission

To promote ethical engagement, mutual respect, and critical reflection on matters of moral concern in health care. We aim for excellence in four interdependent domains of activity: interdisciplinary scholarship, clinical ethics, health policy consultation, and professional and public health ethics education. Compassion and social justice are cross-cutting themes in all that we do.

## Our Values

We embrace the interdisciplinary values of the Faculty of Medicine & Dentistry, the Faculty of Nursing, the Faculty of Rehabilitation Medicine, and those engaged in health ethics scholarship within and beyond the College of Health Sciences.



# History

The John Dossetor Health Ethics Centre has a rich history rooted in interdisciplinary collaboration in ethics education, research, and clinical service.

The Centre was founded in 1985 by the pioneering physician and bioethicist John Beamish Dossetor. As a member of the Faculty of Medicine & Dentistry, Dossetor led an informal Innominate Committee composed of individuals from nursing (Janet Storch, Donna Smith), medicine (David Schiff), chaplaincy (Doug Cossor, Cullene Bryant), law (Ellen Picard, Margaret Shone), and philosophy (Glenn Griener). This group met regularly to discuss challenging clinical cases that exposed the ethics of decision-making. Over time, these meetings spurred planning for a health ethics centre. The Joint Faculties Bioethics Project was launched with the encouragement and support from the Presidents of the University of Alberta, the University Hospitals, the Deans of the health faculties, and the Medical Research Council of Canada in June 1986.

Over the subsequent years, the Joint Faculties Bioethics Project supported interdisciplinary ethics scholarship in education, research, and clinical service. For example, from the cooperation of John Dossetor in medicine, Glenn Griener in philosophy, and Tom Dailey in theology, a clinical ethics curriculum was developed in concert with clinical experts in various medical specialties. A collaborative conference with the Hastings Center bioethics

research institute in 1989 was another highlight from these early years.

In 1990, bioethics was given official status with the creation of the Division of Bioethics. The Division and the Joint Faculties Bioethics Project comprised the *Bioethics Centre*. In January 1998, in recognition of his outstanding contributions to health ethics, the Centre was renamed *The John Dossetor Health Ethics Centre*. The change to “health ethics” from “bioethics” indicated a broader focus on ethics across health domains than the more specialized, technical focus of bioethics.

Vangie Bergum, Faculty of Nursing, is a key figure in the history of the Dossetor Centre. Her research situated ethics within human relationships. She explored the experience of mothering, which led to two books: *Woman to Mother. A Transformation* (1989), and *A Child on Her Mind. The Experience of Becoming a Mother* (1997). Her exploration of relational ethics supported an interdisciplinary research project resulting in the 2005 book *Relational Ethics. The Full Meaning of Respect* (coauthored with Dossetor).

Paul Byrne, from the Faculty of Medicine & Dentistry, has supported the Centre throughout his career at the University of Alberta in clinical ethics; education of students in medicine, nursing, and other health science disciplines; and research projects on such topics as ethical decision making in perinatal medicine.



Wendy Austin, from the Faculty of Nursing, explored core elements of relational ethics and their application in healthcare environments. Her research programs' aims included identifying and exploring relational ethics issues in mental health, developing a relational ethics perspective on research ethics, exploring ways to prepare healthcare practitioners and researchers for ethical practice, and advancing the theoretical basis of relational ethics. Other key individuals from nursing include Janet Kerr, Donna Smith, and Jeanne Van der Zalm.

Dick Sobsey, Educational Psychology, worked to improve healthcare, educational opportunities, and social conditions for people with disabilities and their families. He studied the changes in families that occur as a result of having a child with a significant disability, focusing on positive changes. And he explored ethical and human rights issues, particularly as they are related to people with disabilities.

Gary Goldsand, Brendan Leier, and other clinical ethicists have supported the development of

ethics education, public engagement, and other centre activities. Through the years, the Dossetor Centre has been linked to clinical ethics service delivery as members develop scholarship in ethics to clinical practice.

The Dossetor Centre would not have survived without the commitment and work of administrative leads such as Carol Nahorniak, who has managed the Centre over the years.

The John Dossetor Health Ethics Centre came under the aegis of the Coordinating Council of Health Sciences (renamed Health Sciences Council in 2001) until it moved under the Faculty of Medicine in 2010. Throughout its history, the Centre has benefited from interdisciplinary collaboration, including but not limited to, Nursing, Medicine, Rehabilitation Medicine, Law, Philosophy, and Spiritual Care through its history. The John Dossetor Health Ethics Centre is the only interdisciplinary, academic ethics centre in Alberta, and one of the first in Canada.

Chair in Health Ethics

Michael is the Director of the John Dossetor Health Ethics Centre and an Associate Professor in the Department of Pediatrics. He also has a clinical practice as a physician in neonatal-perinatal medicine with the Stollery Children's Hospital. His research is primarily concerned with relational ethics, situated within the tradition of phenomenology. Michael is considered an international expert in qualitative health research. His

research projects relate to ethical decision-making, the experiential life of the fetus/newborn, the use of medical technologies in clinical encounters, and patient-family experiences of hospital care. Michael is the chair of the Canadian Paediatric Society Bioethics Committee.



**Carol Nahorniak, BSc**

Administrator, John Dossetor Health Ethics Centre, University of Alberta

Carol is the Administrator for the John Dossetor Health Ethics Centre, managing the Dossetor Centre's operations, business, and overall community outreach marketing. She is responsible for the Centre's financial, administrative, and human resource management. **Wendy Austin, PhD**

Professor Emeritus, Faculty of Nursing, University of Alberta

A Professor Emeritus with Nursing and the John Dossetor Health Ethics Centre, Wendy's approach to health ethics is that of relational ethics. She held a Canada Research Chair in Relational Ethics in Health Care from 2003 to 2013 and takes an interdisciplinary approach to studying ethical issues in health care, including from a global perspective. Dissemination of research includes in book form (*Lying Down in the Ever-Falling Snow*) and through film (*Just Keep Breathing* re: moral distress of PICU staff). Recent teaching includes interdisciplinary graduate courses, *Interdisciplinary Healthcare Ethics* and *Research Ethics*. Her clinical expertise is in mental health nursing; she is an editor of *Psychiatric and Mental Health Nursing for Canadian Practice*, 5<sup>th</sup> edition. She has served on The Canadian Nurses Association's Ethics Committee.



**Tracey Bailey, BA, LLB, KC**

Adjunct Professor, Faculty of Medicine & Dentistry, University of Alberta

Tracey Bailey has over 30 years' experience in providing legal, legislative, policy, and ethics advice on a wide range of issues in health law. Tracey is a recognized expert in Life Sciences & Health in The Canadian Legal Lexpert Directory. She has worked in both public and private practice settings, including as Corporate Counsel for Alberta Health, and General Counsel Health Law for Alberta Justice and Solicitor General. She also served in an academic position for close to a decade as Executive Director of the Health Law Institute at the University of Alberta where she conducted a wide range of legal and law reform projects, working locally, provincially, nationally and internationally on a broad range of issues in health law; edited a peer-reviewed publication; taught extensively in the health professional faculties and the law faculty; published on a wide range of topics; conducted media interviews; organized national health law conferences; and provided outreach education for the public and others. In addition to her current work with the Dossetor Health Ethics Centre, she is Associate Counsel with Miller Thomson LLP where she advises health system and health professional clients.

Doris is an Associate Professor and Associate Dean of Theology at St. Joseph's College, the Catholic College at the University of Alberta. Doris teaches ethics and theology in the areas of bioethics, sexuality, death & dying, the body, and women & spirituality. She is also a counselling therapist who maintains a small practice in Edmonton, working with adolescent girls, adult women and men, and couples. Her research and writing include elements of both theology and psychology, moral and ethical decision-making, and human flourishing. All of her work reflects a particular commitment to social justice and the wellbeing of females.

Diane is a Professor and Vice Dean with the Faculty of Nursing, Adjunct Professor with the John Dossetor Health Ethics Centre, University of Alberta. Her program of research focuses on enhancing the ethical capacity of health and organizational policies as these relate to the wellbeing of populations. The methods she employs in this research include qualitative, quantitative and knowledge synthesis, and much of this work has been with interdisciplinary research teams.

Brendan earned his doctorate from the Department of Philosophy, University of Alberta, in 2002. He served for decades as the Clinical Ethicist at the University of Alberta and Stollery Children's Hospitals and Mazankowski Alberta Heart Institute. He is an Adjunct Professor with the John Dossetor Health Ethics Centre. Brendan is presently doing research on the topics of pediatric best interest, psychedelics, moral distress, end-of-life

decision-making, transplant ethics, ethics of medical technology, compassion in the practice of medicine, risk and decision-making.



**Gillian Lemermeyer, RN, MN, PhD**

Assistant Professor, Faculty of Nursing, University of Alberta

Gillian is an Assistant Professor in the Faculty of Nursing. Gillian's current research explores the embodied ethics of healthcare practices, employing a phenomenological method to investigate the nurse's touch in the neonatal intensive care unit. Past research projects have explored the experience of families in the NICU and during the process of considering organ donation. Her nursing background is in neonatal intensive care, family bereavement,

and professional regulation. Her teaching practice is in healthcare ethics and nursing leadership.

**Khaldoon Algerian, MD, MHSc, FCAP, FRCPC**  
Clinical Professor, Department of Laboratory Medicine and Pathology,  
University of Alberta

Khaldoon is a clinical professor of pathology at the University of Alberta, Faculty of Medicine & Dentistry and adjunct professor at the John Dossetor Health Ethics Centre. Khaldoon is a certified pathologist by the College of Physicians and Surgeons of Alberta and Ontario. As well, he is a fellow of the Royal College of Physicians of Canada and the College of American Pathologists. Dr. Algerian is currently a pathologist at the division of Anatomical Pathology, University of Alberta Hospital, Alberta Health Services, Edmonton, Alberta, Canada. He specializes in autopsy and it has paved the pathway to his Master of Ethics at the Joint centre of Bioethics, University of Toronto. **Sarah Anderson, MD, MSc, FRCPC**  
Assistant Professor, Division of Critical Care Medicine, University of Alberta

Sarah is an Assistant Professor in the Department of Critical Care Medicine and Adjunct Assistant Professor with the John Dossetor Health Ethics Centre at the University of Alberta. She completed an NIH-funded postdoctoral research fellowship and a Master of Science in Health Services Research at the University of Pittsburgh and a Bioethics Fellowship at the Harvard Medical School Center for Bioethics. Her research focuses on ethical decision-making in critical illness and enhancing patient and family-centered care across the critical care journey



**Florence Ashley**, BCL/JD, LLM (Bioeth), SJD  
Assistant Professor, Faculty of Law, University of Alberta

Florence is an Assistant Professor at the Faculty of Law and Adjunct Member of the John Dossetor Health Ethics Centre. As a transdisciplinary transfeminine scholar, Florence researches a diverse range of topics relating to transgender communities, with a particular emphasis on law and clinical ethics. Earlier in their career, Florence served as the first openly transfeminine law clerk at the Supreme Court of Canada. Their widely published writings have been cited by the Supreme Court of Canada, in international standards of care, and in United Nations reports. They are the author of *Banning Transgender Conversion Practices: A Legal and Policy Analysis* (UBC Press, 2022). Florence uses they/them pronouns.



**Peter Brindley**, MD, FRCPC, FRCP (Edin), FRCP (Lond)  
Professor, Division of Critical Care Medicine, University of Alberta

Peter is first and foremost a critical care physician. His interests and publications centre on various aspects of resuscitation, including the importance of crisis management and human factors, the use of simulation, and practical insights that improve teamwork during acute care. Peter is a founding member of the Canadian Resuscitation Institute and its vice-chair. He is Western Canada's representative for the Royal College of Edinburgh, and North American Ambassador for Continuous Medical Education. He was first visiting scholar for the Intensive Care Society of the UK. He is secretary of the Canadian Critical Care Society.



**Rose M. Carter**, LLB, KC  
Adjunct Professor, Faculty of Medicine & Dentistry, University of Alberta

Rose brings more than 30 years' experience in the health law field. She assists companies, medical practitioners, as well as scientific professionals, navigate the regulatory requirements of private and public practice, including assisting physicians wishing to expand their practices in to the field of Non-Hospital Surgical Facilities and Telemedicine. Rose has appeared before all levels of courts in Alberta, as well as before various administrative law tribunals. To complement her law practice, Rose devotes substantial time as an active and valuable member of the legal and medical community. She also serves the medical communities across Canada as an executive member of the Medical Council of

Kathryn is an addiction medicine physician at the Royal Alexandra Hospital in Edmonton, AB. She co-developed and was the medical lead for the Addiction Recovery and Community Health (ARCH) Team, an addiction medicine consult service that was first implemented at the RAH in 2014. Prior to this, she worked as an emergency physician at the RAH and Stollery Children’s hospital. Kathryn is currently the Alberta Health Services Chair in Emergency Medicine Research and the Social Accountability Lead for the Faculty of Medicine & Dentistry at the University of Alberta. Her research and advocacy work is focused on improved acute care medical services for people who use substances.

Gary is a Clinical Ethicist in Regina and Integrated Rural Health Saskatchewan Health Authority, and an Assistant Clinical Professor in the Faculty of Medicine & Dentistry and the John Dossetor Health Ethics Centre. He was the previous director of the Dossetor Health Ethics Centre. Areas of interest include ethics education and clinical ethics. He currently practices health ethics in Regina, for the Saskatchewan Health Authority,

and teaches clinical ethics and communications to residents in Internal Medicine, in a 2 week intensive course, offered five times annually.



**Maria Begoña Errasti Ibarondo, PhD**

Begoña is an Associate Professor in the Faculty of Nursing, Universidad de Navarra. Her research is focused on the nurse-patient relationship at the end-of-life; the education of nursing students and generalist nurses for providing person-centered care to people living with advanced or terminal illnesses; and phenomena that are central to health care employing a phenomenological method. Her teaching practice is in pathophysiology, the nurse-patient relationship, and qualitative research.

Associate Professor, Faculty of Law, University of Victoria

Irehobhude is an Associate Professor at the Faculty of Law, University of Victoria and an Adjunct Professor at the Dossetor Health Ethics Centre. She has taught at the Faculties of Law at Western University, the University of British Columbia, and the University of Alberta, and currently teaches and supervises students at York University's Osgoode Hall Law School in the Professional Master of Laws Program. She is the Founder and Director of the *Black Professionals Leadership Program*, an educational support and

leadership training program for Black students at the University of Victoria.



**Ari Joffe, MD, FRCPC**

Clinical Professor, Division of Pediatric Critical Care, Department of Pediatrics, University of Alberta

Ari is a Clinical Professor in the Department of Pediatrics. He is an attending physician in Pediatric Critical Care Medicine. He has interests in animal ethics [e.g., is it morally permissible to perform harmful animal research? (no)], and the definition of death [e.g., is brain death the state of death of the human organism? (no), and is the donation after circulatory death donor dead when organ removal starts? (no)]. His other research interests

are in long-term outcomes in children having complex interventions in the pediatric intensive care unit, focusing on potentially modifiable acute care variables that may lead to improved decision making and outcomes. He has published broadly on these topics and others.



**Cheryl Mack, MD**

Assistant Professor, Department of Pediatrics, University of Alberta

Cheryl Mack, MD is an anesthesiologist and pediatric palliative care specialist. Cheryl is the past chair of clinical ethics for the Stollery Children's Hospital, Mazankowski Alberta Heart Institute, WCM Health Science Centre, and Kaye Edmonton Clinic. She has over 20 years of experience in clinical ethics, professional ethics, and organizational ethics. Her interests include supporting families facing complex medical journeys and the associated challenges with decision making that often accompany

these experiences. Advance care planning and the support of surrogate decision makers is an area of special focus. Academically, some of her current areas of research include drug policy ethics, MAiD legislation and implementation, moral distress and healthcare worker wellbeing, and the ethics of advocacy.



**Stewart MacLennan, RN, NP, PhD**

Associate Professor, Faculty of Nursing, University of Alberta

Stewart MacLennan is an Associate Teaching Professor in the Faculty of Nursing at the University of Alberta and Nurse Practitioner in Alberta Health Services Correctional Healthcare. 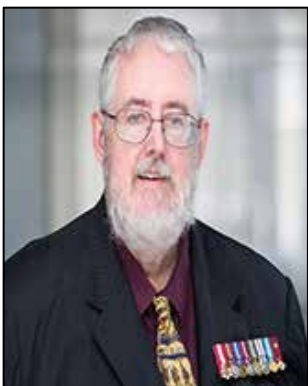
developing effective therapeutic relationships in distrustful milieus.

# Clinical Service

Ethics are fundamental to the clinical delivery of health care. At times, we recognize ethics when health care professionals or their patient-families are faced with difficult choices in the course of treatment. Other times, it is situations of uncertainty that necessitate the services of clinical ethics.

Clinical ethics services help patients, families, and health care providers address such questions as: What is the right thing to do? How should a decision be made? Does a reasonable compromise? In addressing these questions, clinical ethics services aim for compassion, accountability, respect, excellence, and safety.

Since its inception, the John Dossetor Health Ethics Centre has supported the delivery of clinical ethics to the University of Alberta Hospital, and, over the years, specifically at the Mazankowski Heart Institute, Stollery Children's Hospital, Walter McKenzie Health Sciences Centre, and Edmonton Clinic. That said, Clinical Ethics at the University of Alberta Hospital is a distinct entity to the Dossetor Health Ethics Centre under the umbrella of Alberta Health Services.

Members of the John Dossetor Ethics Centre who also serve as clinical ethicists or members of clinical ethics committees may use themes identified from clinical ethics to serve the Centre's mandates of education, engagement, and scholarship.

# Education

The John Dossetor Health Ethics Centre supports ethics education within and beyond the Faculty of Medicine and Dentistry.

## **Classroom-based Ethics Teaching**

**Undergraduate Health Ethics Seminar Teaching** The Dossetor Centre offers instructional academic sessions on medical ethics teaching. These sessions are directly related to ethics content requirements for accreditation in the Faculty of Medicine and Dentistry. Members of the Dossetor Centre also support ethics education in Nursing and other disciplines at the University of Alberta and St. Joseph's College.

**Postgraduate Health Ethics Seminar Teaching** The Dossetor Centre offers instructional academic half-days sessions for residency and subspecialty residency programs. These sessions are focused to the needs of the residents. This also includes an annual 2-week health ethics course to internal medicine residents.

**Graduate Courses in Health Ethics** In collaboration with the Faculty of Nursing, the Dossetor Centre offers two semester courses in health ethics on a biannual basis: Healthcare Ethics (INT D 570) is an interdisciplinary course exploring selected topics in bioethics. Includes examination of ethical theories and principles within the context of clinical practice (nursing, medicine, rehabilitation medicine, dentistry, pharmacy) and learning experiences to improve moral reasoning and ethical decision making. Research Ethics (INT D 670) examines the ethical issues which arise in research involving human subjects. Research methods studied may include clinical trials, surveys, secondary analysis of stored data, and the observation of public behavior. Problems encountered in studying particular populations, such as children or persons with dementia, will also be studied. Faculty of the Dossetor Centre also support the delivery of other graduate courses in health ethics such as Contemporary Issues in Healthcare Ethics and Law (NURS 422).

## **Clinical Ethics Teaching**

**Undergraduate Health Ethics Electives** The Dossetor Centre Health Ethics Electives are the only undergraduate health ethics elective offered in Canada. The options range from: a reading course accompanied by discussions of the ethics issues in the literature (e.g., issues in reproductive ethics, geriatrics, neonatal problems, or human experimentation); direct experience of a specific practical problem in health care ethics by first-hand exposure; or, a combination of these. Students normally focus their conclusions by writing a position paper in the last week of the elective.

**Postgraduate Health Ethics Electives** The Dossetor Centre offers ethics electives to residents and subspecialty residents. Interested graduate students may also partake in health ethics electives.

**Rosemary Altobelli, RN**

Rosemary Altobelli is completing graduate studies toward a master's degree in nursing in the neonatal nurse practitioner stream in the Faculty of Nursing at the University of Alberta. Rosemary's capstone project is focused on a critical review of the literature that describes the emerging use of artificial technologies to assess the pain of babies in the neonatal intensive care unit. Her project acknowledges that relieving pain for an NICU baby is more than a medical or developmental importance, it is also a matter of ethics.

Gloria Brook graduated from the Faculty of Nursing at the University of Alberta in spring of 2023. Her capstone project focused on reviewing the literature of moral distress as experienced by NICU nurses. Specifically, Gloria explored the experience of caring for babies whose care has been deemed futile. The project concludes with a plan to develop an education module to support NICU nurses to recognize and prepare for the experience of moral distress.

Janine Chesworth is a pediatric Speech-Language Pathologist (SLP). Her early education classroom experience has included both co-teaching and consulting in addition to clinical education at the University of Alberta. She also has special interests in Developmental Trauma and motor speech disorders including Childhood Apraxia of Speech, Oral Myofunctional disorders and Developmental Dysarthria. Since 2013, Janine has provided early-learning SLP to Indigenous communities both on and off reserve. ### Editor's Forum

How do we understand the meaning of ethics in rural and remote healthcare contexts? To what extent have traditional health ethics discourses passed over the nuances of practicing in these settings? What can urban-centric healthcare providers learn from those who practice in such communities? How do we build on the strengths inherent in rural and remote contexts, particularly as we face crises in human and material resources in our healthcare system?

These questions are addressed in this issue of *Health Ethics Today*, which is composed of two contributions from the John Dossetor Health Ethics Centre Symposium "Rural and Remote Healthcare Ethics: Considering Issues for the Past, Present, and Future", a virtual event held on November 28, 2023. The first article is co-authored by Fiona McDonald, an Associate Professor in the Australian Centre for Health Law Research at Queensland University of Technology, Australia and Adjunct Associate Professor in the Department of Bioethics at Dalhousie University, Canada; and, Christy Simpson, an Associate Professor in the Department of Bioethics at Dalhousie University and Adjunct Professor in the Australian Centre for Health Law Research at Queensland University of Technology, Australia. Both have worked to advance health ethics discourse regarding rural settings, and are co-authors of the book *Rethinking Rural Health Ethics* (2017). The second contribution is from Jill Konkin, a Professor of Family Medicine in the Faculty of Medicine and Dentistry at the University of Alberta, Canada. For over 20 years, Jill Konkin has worked as a rural generalist family physician. Throughout her career, she has advocated
