

## Clinical Elective Diversification Policy

<b>Scope:</b>	Compliance with this policy extends to all medical students.

### OVERVIEW

Electives are an important and mandatory component of the MD Program. They provide opportunities for medical students to explore medical domains in a more in-depth fashion than may be permitted in the core clerkship. Medical electives allow students to develop their own specific interests and expertise, as well as sample disciplines for possible career choices and postgraduate training programs.

### PURPOSE

Clinical electives permit medical students to gain exposure to and deepen their understanding of medical specialties reflecting their career interests, and also provide opportunities for medical students to pursue individual academic interests. This policy is related to the MD Program's overall [Electives Policy](#).

### POLICY

#### 1. RESPONSIBILITY

- a. University of Alberta medical students request local electives through Cally and visiting electives through the AFMC Portal.
- b. The Coordinator, Electives & Selectives monitors the quality of student elective experiences.

#### 2. ELECTIVE DIVERSIFICATION

- a. Students are strongly encouraged to use electives to pursue a broad range of interests in addition to their chosen specialty. As a result, the University of Alberta MD Program will subscribe to the national initiative to limit the maximum number of clerkship electives in one CARMS entry-level discipline to 8 weeks. An entry-level discipline is an Entry Route in the PGY-1 (R1) match. Each of these entry-level disciplines leads to specialty certification with either the RCPSC or the CCFP. This elective diversification policy extends to any clinical elective, including international electives and exchanges.



- b. Electives in subspecialties that are part of a PGY-3 (R3) match (e.g. Pediatrics or Internal Medicine subspecialties) are counted as separate disciplines to a maximum of 8 weeks in GIM and/or Pediatrics. These do not count towards the eight week cap in general Pediatrics and/or Internal Medicine.
- c. One clinical research elective of two weeks can be approved by the Coordinator, Electives and Selectives and count towards the electives requirement.
- d. Clinical electives must be a minimum of two weeks duration.
