8. Proposed Non-Credit Executive Certificate in Municipal Leadership, Faculty of Business

9. Undergraduate Embedded Certificate Framework

Materials before members are contained in the official meeting file.

Discussion:

The Vice-Chair noted that PC recommended approval of this framework on February 9, 2023 but at the March 20, 2023 meeting of GFC, members raised concerns about the proposal and it was withdrawn to allow for additional consultation. He explained that the proposal had been revised with some minor edits and to allow additional time for existing certificates to be brought into compliance with the framework.

J Causgrove Dunn spoke about the additional consultations and the diverse feedback received as well as the changes made to the framework. She noted that the most consistent concern was about the implementation timeline of fall 2024. She informed members that the Embedded Certificate Working Group was reconvened to consider additional feedback received and agreed with the revised proposal and extended deadline. She noted her commitment to work closely with existing embedded certificate holders to ensure that their certificates could either be brought into alignment or transformed into another type of credential. She also reiterated that the purpose of this framework was to establish a cohesive purpose and design which would increase accessibility, add value, and enhance the learning experience of students.

Members spoke in favour of the framework and asked that the changes related to credit weight and overlap be highlighted in the materials going forward to GFC.

The motion was moved and seconded.

THAT the GFC Programs Committee reconsider the motion to recommend that General Faculties Council approve the Undergraduate Embedded Certificate Framework that was approved at the February 9, 2023 meeting.

THAT the GFC Programs Committee recommends that the General Faculties Council approve the proposed Undergraduate Embedded Certificate Framework, as set forth in Attachment 1 to take effect immediately with compliance of existing embedded certificates expected by Fall 2025.

10. <u>Quality Assurance (QA) Suite of Activities: 2021-2022 Excerpted QA Reports from the Arts; Faculty of Medicine and Dentistry; Faculty of Native Studies; Faculties of Science and Medicine and Dentistry</u>

Discussion:

J Causgrove Dunn explained that the GFC Academic Planning Committee (APC) currently held the responsibility to review Quality Assurance (QA) reports in their terms of reference but that the governance team asked that this discussion also come to Programs Committee because of their responsibility over programs. She spoke about the nine program reviews that were conducted over the 2021-22 academic year and acknowledged the hard work of the program administrators, and the external and internal review members. J Causgrove Dunn also pointed out that the UofA has embedded the requirement to document Indigenous, and Equity, Diversity, and Inclusion initiatives into the QA process and that even though this is not currently required by the Campus Alberta Quality Council (CAQC), they are looking into making it a requirement. She spoke about some of the recommendations in the reports related to Indigenous Initiatives and teaching, learning, and student experience. She also noted student engagement in the process and the positive feedback received from students.

Members discussed:

- These public reports are available on the Office of the Provost's website;
- Program-specific academic advisors in the Faculties and Departments;
- Whether there was any regular follow-up on the recommendations;
- The work of the student experience action plan group;
- The responsibility of the Deans and Chairs to follow up on the recommendations and the CAQC Handbook's recommended annual internal review of progress;
- How this process could be best placed within the GFC Committee structure; and
- The importance of thinking beyond legislative compliance and toward using the information gained in the process to make the University better.
- 11. External Programs for Review and Programs in Progress on Campus: Standing Item (no documents)

C Roth provided the following report:

- We are in the process of reviewing one external program proposal from The King's University for a new Bachelor of Kinesiology degree program.
- Since our last meeting, the Ministry has approved one new program:
 - Dental Assisting Certificate; and
- two suspensions:
 - o Graduate Certificate in Stroke Rehabilitation, and
 - Graduate Certificate in Bridging to Canadian Physical Therapy Practice.
- Since our last meeting, the proposal for a new Bachelor of Biomedicine remains with the Ministry for review and approval.
