#### Discussion:

The Chair introduced the item, advising members of President Flanagan's recent decision to put his name forward to serve a second term as President. The Chair indicated that, as required by the university's Presidential Review Procedure, she had initiated a review process by calling for the establishment of a presidential review committee.

The Chair then briefed members on the timeline and process for finalizing the review committee's composition. She noted that as part of the process, the board was responsible for appointing two of its members to the review committee, and reviewed the proposal before members. The Chair suggested that members of the committee and the Board of Governors both participate in voting for the following motions.

The motion was moved and seconded, as amended.

THAT the Board of Governors and the Board Human Resources and Compensation Committee, on the recommendation of the Board Chair, approve the appointment of Guy Bridgeman and Margot Ross-Graham to the Presidential Review Committee, in accordance with sub-paragraph 1.c. of the Presidential Search and Review Procedures (Appendix A): Committees for President Position Definitions and Eligibility, effective upon approval.

#### CARRIED

The Chair then briefed members on the proposed set of guidelines and procedures intended to guide the review committee throughout the 2024 presidential review process.

The motion was moved and seconded, as amended.

THAT the Board of Governors and the Board Human Resources and Compensation Committee, on the recommendation of the Board Chair:

- i. approve the Presidential Review Committee Guidelines and Procedures (the "Guidelines and Procedures"), as set forth in Attachment 1, and
- ii. authorize the Board Chair, in her capacity as chair of the Presidential Review Committee, to provide the Guidelines and Procedures to the Presidential Review Committee as required by sub-paragraph 4.a. of the Presidential Review Procedure.
