## <u>Adjournment</u>

The GSA is aware of—and shares—concerns surrounding yet another proposal for increasing tuition at the University of Alberta. The increasingly untenable tuition prices at the University of Alberta, particularly when taken in conjunction with the ever-increasing cost of living, are a significant priority for the GSA and have been the primary topic of countless meetings. Graduate students are an immense asset to any Canadian research university but over the past months and years, we have faced repeated blows to our efforts to not only advance knowledge in our chosen fields, but to continue doing so without significant harm to our physical and mental wellbeing.

At the same time, the University has responded with research that indicates that tuition at U of A is lower than the national average. As you'll recall, in November 2022 GSA Council members were joined by Melissa Padfield (Deputy Provost, Students and Enrolment), who gave a detailed presentation on this issue (see Items 5 and 6 in the <u>GSA Council November 2022 materials</u>). The University asserts that its 2022-2023 tuition rates (for Fall 2022 intake) are lower than the average (excluding U of A) rate of the U15 Group of Canadian Research Universities.

The fact remains that the current proposal to increase tuition will impact segments of new and returning students. What's more, this proposed increase continues a trend of tuition increases that began in 2019 following an extended period of domestic tuition freeze by the previous NDP government. Since then, the current government has implemented changes that will shift the balance such that the University receives the bulk of its funding from tuition, rather than from public funds. To highlight this, since the 2018-2019 academic year, the province's contribution to the operating budgets of post-secondary educational institutions across Alberta has decreased from \$2.43 billion to \$1.97 billion, or by 18.8%.

The GSA is currently engaged in compiling the most salient data related to the current tuition hikes and the rationale underpinning them. We look forward to bringing these to the graduate student body as soon as possible, so that our discussions and intentions for future projects and initiatives are as informed as possible.
