**Course Description and Objectives:**

*This directed studies course on Space in Russian culture (Russ 499) discusses issues of space (public and private) as represented in various authors (writers and theorists); the course considers diverse media (literature, film, TV, other visual culture) Each weekly class combines lecture and discussion.*
